I am the Petitioner in the above-referenced Domestic Violence, Family Division case and an observer with knowledge of the facts in the County Court Eviction Case.

As an investigative journalist, I search for the truth and report it. As a citizen, I contribute toward protecting our constitutionally guaranteed unalienable rights to the pursuit of happiness.

Having found peace and tranquility following my search for the ideal lodge to write my story and complete a major book project, my dreams were shattered by the happenings since my arrival at this idyllic place in the Redland of South Florida in late May.

I am delivering a copy of this letter to Gregory Duque to who is squatting with his nine dogs outside the western boundary fence of Litchee Farm, a tropical fruit tree grove, at 16655 SW 203 Avenue, Miami, FL 33187 to his two email addresses at gduquw55@yahoo.com and dugreg25@gmail.com. my November 1 letter triggered a vicious attack by Gregory Duque who warned me of arrest because I “come within 500 feet in violation of the restraining order” Gregory Duque has secured against me. Since respecting the truth is not in the cards, I decided to withdraw the courtesy of hand-delivery on this occasion.

In my November 1, 2014 correspondence I raised the question of mental illness and the Baker Act. The results of my research confirmed my concerns and fears and, more importantly, strengthened my resolve to dedicate my energies to protecting our community from further agonies and combining it with doing the utmost to return Gregory Duque to a healthy and productive life and the grand lifestyle.

Mr. Duque is not employed. His last employment was several years ago as a locksmith. It is my understanding the privilege of being employed as a locksmith and holding the corresponding license was taken from him by appropriate authority.

The 53-year-old Gregory Duque is presently receiving \$721 monthly Supplemental Social Security Income Payments because he is a “disabled individual” which is now subject to investigation.

Based on his own representations, supported by facsimile messages from the doctors’ offices, Mr. Duque underwent outpatient medical procedures on August 29, 2014 and September 12, 2014 to remedy his “disabling” ailments. The August 29 procedure was carried out by Dr. Barry E. Shapiro of Advanced Orthopedics in Hollywood (954-987-2047) and the September 12 procedure was performed by Dr. Reuter of Whitesand Orthopedics (954-586-5202) at the Broward Outpatient Center.

Both procedures were carried out in minutes and, as Mr. Duque tells everyone “each brief operation (not performed under full anesthesia) cost one hundred and ten thousand dollars (\$110,000).

I am prepared to give sworn testimony to the following:

1. All statements made in this correspondence.
2. On September 20, 2014, Gregory Duque committed assault and battery on Rudy Salmi unhindered by a physical disability.
3. On October 17, 2014, Gregory Duque attacked and committed battery on Heinz Dinter unhindered by a physical disability.
4. At the present time, Gregory Duque is engaging in many types of manual physical labor which do not indicate disability.

My concern over Gregory Duque’s sincerity and honesty prompt me to question our urgent need to render assistance to Gregory Duque, and I shall withhold mine until Gregory Duque admits he has a mental health problem and asks for help.

With respect to major problems of health and efforts to secure a cure, I subscribe to the dictum. You alone can do it, but you cannot do it alone.
